Dear Mr. Steinberger:

I am writing to let you know how very pleased I am with the work you are doing on my case and our progress so far. My husband and I have been trying to negotiate our divorce for over two years. I was, honestly, blown away by the results. It took a good 8 hours, but the tentative child support numbers we all agreed on far exceeded my husband's proposed amount and exceeded all of my expectations. I was shocked at the amount, when the day was over. When you get down to it, it was all you, Chaim --- you went into the meeting on the side of fairness and respect, not haggling and throwing insults. My husband's lawyer was deal making and arguing everything we tried to say or propose. How do I know it was all you? When my husband held his hand up to his lawyer's face for her to stop speaking, so he could listen you what you were saying, then agree with you. I knew you had convinced him of the fairness of the child support agreement we put together that day. It felt good to know that we all agreed to what was best for our children, not what deal one side gave in to because the other yelled louder.

I would highly recommend your services to anyone beginning the divorce process.
